<p>Reducing exposure to triggers within the home is a complex issue for renters. There are actions that the renters can take to reduce exposure to triggers; however, there are many times when action may need to be taken by the landlord as well. For example, if there are mechanical or structural problems leading to leaks and mold or opportunity for pest infestation, then action needs to be taken by the landlord. Programs provide loans for physical modifications to the homes of elders, adults with disabilities, and families with children with disabilities. Asthma may qualify as a disability depending on severity. Restrictions apply.
